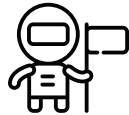

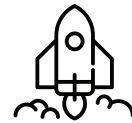

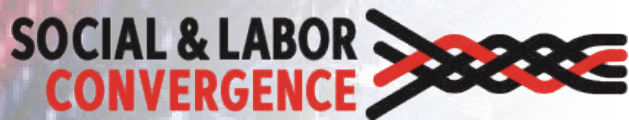

During Production Inspection (DUPRO), takes place from 20-80% of your production is completed and packed for shipping.

DUPRO Inspection ensures production is taking place properly, and whether factory is following your original specifications/Sample correctly or not. It's can confirm if, the production match with the shipment schedule.

Final Random Inspection (FRI)

Final Random Inspection (FRI) is performed when 100% production complete and at least 80% packed and 20% in packing.

Final Random Inspection (FRI) provides a final opportunity to look into the quality, conformity, compliance and other attributes of the products and to take corrective action before the product shipment.
